

Village 1 Redevelopment – New Aged Care Centre

June 2024

All the specialist consultants required to assist in developing the buildings design and support services, and SSDA submission have now been commissioned.

The architects have continued developing the buildings appearance and floor plans. The design will now be finalised after further consultation with the specialist consultants, including kitchen & laundry layouts, structural system and building services.

Detailed site investigations will be undertaken to determine the sites ground conditions, including monitoring for groundwater levels over a few months and testing for contamination.

Because our site is shared with St Maroun's College conditions from the recent Development Approval also affect our development. Principally this relates to the heritage brick boundary wall and stormwater drainage.

Before the end of the year works are likely to begin to stabilize the brick boundary wall, enlarging the entry gates opening and upgrading the sites stormwater infrastructure.

Many of the studies and consultant investigations required for the SSDA will take months to complete. We are targeting to submit our SSDA in November 2024.
